This reservation is for tableside bottle service outside during Wake Wars 2011, July 16 or July 17, which includes a designated VIP section, personal server, mixers (including six cans of Red Bull per bottle of Absolut), condiments and complimentary express entry into The B.O.B. Cover charge into The B.O.B. will be waived for your group when your minimum purchase is met. A minimum spend of \$160 is required per each section. A 20% gratuity will be added to the total bill for service.

3. Partially-consumed bottles of alcohol may not be held for future use, are not permitted outside of your bottle service section and are forfeited at conclusion of Wake Wars.
4. All orders by any guests in a VIP section are ultimately the responsibility of the Person in Charge of the reservation of said section.
5. Any incidentals or damage will be charged to the credit card on file. Guests deemed over-intoxicated may not remain on the property.
